**Part I, Question 10 - "Grants and Similar Amounts Paid" & Part III, "Statement of Program Service Accomplishments"**

\$42,125 was transferred to Amis des Bibliothèques de Villages Africains of Burkina Faso, a local non-profit,

that is our partner in Burkina Faso. The funds supported ongoing operations in 13 village libraries, and summer reading

camp and cultural and literacy programs. Twenty-one new libraries, in provinces of Bam and Sanmatenga, and village of Sebba, were

developed in 2015. Some of the funds were used to support the small multimedia center in Houde, that produces books for libraries.

The grantee's mailing address is c/o Sanou Dounko, Coordinateur, Amis des Bibliothèques de Villages

Africains, 09 BP 938, Ouagadougou 09, Burkina Faso. (Form 990-EZ, Part III, Line 28)

\$7,000 was transferred to CESRUD, Center for Sustainable Rural Development, a local non-profit based in Bolgatanga, Upper East region,

Ghana, that is our partner in Ghana, to implement operations in three libraries and reading programs. The grantee's mailing

address is c/o Paul Ayutoliya, Sumbrungu Community Library, c/o CESRUD, Box 267, Bolgatanga, Ghana. (Form 990-EZ, Part III, Line 30)

\$12,000 was transferred to the Kitengesa Community Library and UgCLA (Uganda Community Libraries Association), c/o National Library

of Uganda, P.O. Box 4262, Kampala, Uganda. Kitengesa Library continued normal library services. UgCLA conducted

several librarian workshops and managed grants for improvements for its community member libraries. (Form 990-EZ, Part III, Line 29)

\$1,399 was spent to support operations of the Chalula Community Library (PO Box 993, Dodoma, Tanzania, East Africa). This

amount was administered by PEN Trust (c/o Poverty Eradication Network of Tanzania, 8924 - 40 1/2 Avenue North, New Hope, MN 55427) a

501c(3) organization which conducted oversight visits and evaluations of library operations on FAVL's behalf. Funds were used to

pay librarian salaries, library scholar stipends, newspaper subscriptions, and operating expenses at this community library in the village of

Mvumi. The village chose at the end of 2015 to close down the library and use the hall for a classroom. (Form 990-EZ, Part III, Line 31)
